IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball under the auspices of Minnetonka Paintball Adventure, I acknowledge, appreciate, and agree that:

1. The risk of injury from the activity and weaponry involved in paintball is significant and while particular protective equipment and personal discipline will minimize this risk, the risk of injury does exist.

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability below, and assume full responsibility for my participation.

3. I understand that activities of paintball are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical.

4. I, for myself on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE Minnetonka Paintball Adventure, the owners of the premises used to conduct the paintball activities, the officers, agents and/or employees ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, or DEATH, or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the result of gross negligence and/or wanton misconduct.

5. I understand and will comply with Minnetonka Paintball Adventure Field Rules and Safety Guidelines. Failure to do so will result in me leaving Minnetonka Paintball Adventure willfully and without refund of any kind.

6. I understand and agree that this Release of Liability Agreement covers each and every paintball activity and event in which I participate hereafter.

7. I understand that this is an extra cost activity and is not covered by my camping fee. Additional paint balls can be purchased for use during the session or after the session for "target practice", but may not be taken from the paint ball area. Only equipment and paint balls provided by MCC may be used.

8. I acknowledge that I understand the participant must have had their 10th birthday in order to participate.

I AND MY PARENTS HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
